

ORDINANCE NO. 2013-274

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF GILBERTVILLE, IOWA, BY AMENDING GILBERTVILLE TRAFFIC CODE SECTION 69.08 (NO PARKING ZONES), TO ADOPT AND APPROVE TWO ADDITIONAL NO PARKING ZONES ON 5TH STREET. SEE GILBERTVILLE CODE SECTIONS 69.08(11) AND 69.08(12), BELOW.

BE IT ENACTED by the City Council of the City of Gilbertville, Iowa:

SECTION 1. SECTION MODIFIED. The Code of Ordinances of the City of Gilbertville, Iowa, is hereby amended by adding subsections (11) and (12) to Gilbertville Traffic Code Section 69.08 as noted below;

69.08 NO PARKING ZONES. No one shall stop, stand or park a vehicle in any of the following specifically designated no parking zones except when necessary to avoid conflict with other traffic or in compliance with the direction of a peace officer or traffic control signal.

1. 25th Avenue, on both sides, from First Street to Second Street;
2. First Street (Cemetery Road), on both sides, from Highway 297 to 15th Street;
3. Gilbertville Road, on both sides, from 10th Avenue to the south City limits;
4. 10th Avenue, on both sides, from 5th Street to the east City limits;
5. 5th Street, on both sides, from 14th Avenue to 20th Avenue;
6. 9th Street, on the east side, from 10th Avenue south, including the cul-de-sac;
7. 20th Avenue, on the north side, beginning at a point 405 feet west of the centerline of 5th Street, from that point of beginning west around the curve to Raymond Road and City limits;
8. 20th Avenue, on the south side, from the centerline of 5th Street west 380 feet;
9. 20th Avenue, on the south side, from the centerline of 1st Street east 282 feet;
10. From 10 feet west of the entrance to the hammerhead (cul-de-sac) turn-around located at the east end of 12th Avenue (designated by painted yellow curb) and throughout the entire hammerhead (cul-de-sac) turn-around;
11. 5th Street, on the east side, from 20th Avenue to 21st Avenue;
12. No parking, except Sunday and Holidays, on the west side of 5th Street from the centerline of 21st Avenue to the south intersection of 20th Avenue, then continuing west on the north side of 20th Avenue to the No Parking Zone beginning 405 feet west of the centerline of 5th Street.

SECTION 2. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.


SECTION 3. WHEN EFFECTIVE. This ordinance shall be in full force and effect from and after its final passage, approval and publication as provided by law.
