**Electronic Funds Transfer (EFT) Program**

All families are asked to participate in EFT payments for the 2021-2022 school year.

The EFT Program is quite flexible in that it allows money to be transferred on the 5th or the 20th of each month. The same dates can be used for quarterly EFT.

Of course, full payments will be accepted at the beginning of each year. There will be a policy to work with each family individually to assist with their needs.

This is our EFT system. We do NOT use a privately run system that would cost our families additional money!

The EFT system allows for better cash flow for the Bosco Catholic School System. It saves many phone calls and letters concerning tuition.
